Exploring the key role of municipal governments in the selection, operation, and financing of public infrastructure in Canada, the authors critically assess the considerable unrealized borrowing capacity available to municipalities and the impacts of a shift towards increased borrowing, away from a reliance on intergovernmental grants.

Business Cases for Infrastructure Projects: What are They? Who Needs Them? And What Happens When They're Not Done Properly?

At a time when governments are proposing to spend (and in some cases already spending) billions on transportation and other infrastructure in the GTA and elsewhere in the province, it is worth reviewing business case practices in this area and whether they are up to the task of providing sound guidance to our elected officials and policy makers that are allocating public funds to a potentially wide range of infrastructure projects. Business cases are essentially the body of evidence needed to justify approval and public funding of projects under consideration. This means deciding whether a project will make us better off as a society; and whether or not the public funds are better spent on other projects or even other uses.
