#### Desire2Learn:

#### **Course Description:**

This course examines the links between economic activity, energy use and environmental degradation. This course will explore a range of issues surrounding energy development and use and environmental quality. The topics will include energy technologies ranging from extraction, processing and transportation, energy efficiency, markets and externalities, the measurement and treatment of environmental issues and standards, the valuation of environmental amenities, the use of incentives in regulation, the economics and environmental effects of market failure and the rationale for government intervention. Economic theory will be used to inform the analysis of behaviour and the design of policy instruments.

The aim of the course is to introduce students to economic principles and techniques which are of use in analyzing and planning energy and environmental policy, and to develop skills in critical evaluation and evidence-based policy decision making.

A passing grade on any one component is not required to pass the course.

Further instruction on methods of submission and due dates will be provided in class and on D2L. Be sure to check D2L each week for readings and assignments.

### **Policy Paper Critiques**

Students will be responsible for writing two critiques of energy or environmental policy papers over the course of the semester. Students can choose policy papers from any public policy institute, think tank, or academic journal, subject to the instructor's approval. The critique must evaluate the question(s) and answer(s) posed by the author of the policy paper, and restrict the analysis to the topic of the paper. Specifically:

- 1. Are there important points the author failed to address?
- 2. Is the argument logical?
- 3. Is the solution good public policy?

The critiques should be short; no more than fifteen pages. Grades will depend on your framing of the issues, integration of course content, originality, quality of research, and clarity of writing. Further details including due dates will be available on D2L.

### Presentation & Informational Briefing Note

Students will prepare a short presentation, as if to a parliamentary committee hearing. Students will present an analysis of a current regulation or policy, focusing on providing information. The presentation should be a maximum of ten minutes. Presenters will also prepare a short briefing note in support of the position being presented. Further details will be available on D2L.

## Briefing Note with Recommendation

Students will prepare a short briefing note, presenting an analysis of a current regulation or policy and recommendations for a policy change. Further details will be available on D2L.

*Grading\**: Letter grades as described in the Faculty of Graduate Studies Calendar (see section E.1 of Calendar online) will be given for all elements of grade determination noted above. The course grade will be determined based on a weighted average of those grades according to the percentages shown above. In the event that elements are marked on a numerical (percentage) basis, they will be converted to letter grades. ## **Classes and Readings:**

The course will consist of a combination of lectures, class discussion and guest presentations. The discussion will be based on readings available from the textbooks, articles ranging from peer reviewed journal articles to topical or popular journal articles, and other materials. Reading will be extensive and will span a range of disciplines from economics and finance to science and engineering. Students should expect to critically review and analyze readings and other material. There will be occasional guest speakers to lead discussions on various topics in term.

A course syllabus will be provided at the first class, outlining the schedule of topics. Assigned readings will be indicated in a reading list posted on D2L at least a week in advance of the lecture.
