What is a school of public policy?

A school of public policy brings together scholars and practitioners interested in finding sound and practical solutions to the public problems that a society faces, using the methods of science. At the junction of different disciplinary traditions such as economics, public administration or law, policy research is usually strongly empirical and aimed at informing public deliberations and government decisions. In addition, most schools host one or more teaching programs, providing future analysts with the knowledge and skills required to develop and implement policies in a variety of organizations, public or private.

Master of Public Policy

The centrepiece of teaching and training at the School is the Master of Public Policy (MPP) program. Established in 2011, the program is a one-year, course-based, professional Master's program. Such programs are growing in popularity in Canada and elsewhere as students opt for graduate programs that are shorter in duration and designed to prepare them for an immediate career.

MSc in Sustainable Energy Development

This new academic year will see the arrival of the very successful Master of Science in Sustainable Energy Development (SEDV). The program provides students with a graduatelevel understanding of the science and policy aspects of sustainable energy. The program is truly interdisciplinary and involves the active participation of the Haskayne School of Business, the Schulich School of Engineering, the Faculty of Law, and the School of Architecture, Planning and Landscape.

Extractive Resource Governance Program

The Extractive Resource Governance Program (ERGP) offers international training and capacity-building programs tailored to the specific needs and timelines of different countries. These programs provide objective advice, based on Canadian and international best practices, to educate officials involved with developing their resource sectors.

Executive Training

In the next years the School will establish academic credit certificate courses in health policy and energy policy. These will be aimed at professionals at work in these fields who wish to upgrade their academic knowledge.

In addition, the School will explore a part-time MPP stream as well as a Doctor of Public Policy degree.
