Alan MacDonald

He was the Lead for the LNG Canada front end engineering design (FEED) team for the development and completion of permits, environmental management plans, and social performance initiatives in 2014-15. LNG Canada in Kitimat, B.C. is the only major LNG project of more than 30 proposals on B.C.'s west coast to achieve both positive regulatory and investment approvals to date.

Alan has worked extensively with aboriginal organizations and companies in Canada, including the development of national-level aboriginal capacity building curriculum and materials. He is also the co-author of numerous social and environmental guidelines, including guidance documents for the CCME (Canadian Council of Ministers of the Environment), ARPEL (Regional Association of Oil, Gas and Biofuels Sector Companies in Latin America and the Caribbean); Environment Canada; Alberta Energy and Utilities Board, CAPP (Canadian Association of Petroleum Producers); Alberta Reclamation Research Technical Advisory Committee; Alberta Treaty Nations Environmental Secretariat, as well as government departments and mining, construction and energy companies in Canada and abroad.
